**DIRECTION FOR USE:**

Apply specified dosage as a dormant application in a minimum of 10 gallons of spray per acre by air for the control of annual weeds in grapes. Make applications when weeds are succulent and growth is from 1 to 6 inches high. Add a nonionic surfactant containing 50% surface-active agent at 1-2 pints per 100 gallons of the finished spray volume.

**RESTRICTIONS:**

- Maximum Single Application Rate: 1.3 pt/A
- REI: 48 hours
- Minimum Application Interval: Not Applicable
- Maximum Annual Rate: 1.3 pt/A
- DO NOT exceed 0.5 lb ai/A/year of paraquat-containing products.
- DO NOT make more than one application per year.
- Pre-Harvest Interval (PHI): Harvest crop at normal harvest maturity.
